

#### WOULD CONTINUE **ROADS THROUGH**

Legislation to open two present dead-end streets, Profit avenue and Salter street, was pressed. into action Wednesday of last week by the Township Committee. Two resolutions were adopted and ordered sent to the Board of Freeholders, netitioning the county body to erect, bridges over a stream in Profitt avenue, and another on Salter street, near Brook street.

Such construction, which could be accomplished in the Spring, would enable the committee to have Profit avenue extended several hundred feet, thus connecting the thoroughfare from Morris-avenue to Bryant avenue. In Salter street, a bridge






