# **Melick Winner** At Regional; **Bertolamy** Out

## **Banyasz Defeats Bd.** President; Budget Approved Wins Sales Honor

Three new members and Commissioner William J. Melick, of this township, will be inducted when the Regional Board-of Education reorganizes this month.

Melick in the annual election-Tuesday defeated-Recreation Commissioner Edmund Hoffert for the seat by a margin of better than two to one. The final tabulation was 191 to 91.

The big-upset, however, of-the Regional-district occurred in Garood where Commissioner Bertram J. Bertolamy, board president, was defeated by John Banyasz, in a hotly contested election which had both Republican and Democratic factions in the borough working stronuously to turn out the vote The final tabulation showed Bertolamy\_had\_lost\_361\_to\_299, There



## Amount to Be Raised **Shows Increase Over Total Figures in '52**

The 1953 municipal budget, showing a complete total \$1,030,062:38 as compared to \$975,798,76 for 1952, was introduced by the Township Committee at a special meeting held last night but the estimated tax rate for 1953 will be \$8.15 as compared to \$8.41 in 1952. This tax rate is a leorease of 26 points which is attributable to a decrease of 52 points for local schools, a decrease of 11/2 points for Regional High School, an increase of 21/2 points for the County and an increase of 25 points for local purposes.

The new budget and tax resolution was approved last hight and a hearing will be held at the Municipal Building at 8:30 p.m., March 4 at which time objections may be presented by taxpayers or other interested persons.

The amount to be raised by axation for local school district purposes for 1953 is \$388,134.74, a rease of \$28,587.99 compared to 1952. This provides for local school district taxes and the deficiency in basic aid to the local school district.

tion for the Regional High School district for 1953 is \$113,482.78, which is an increase of \$8,168 over 1962. For county taxes, the amount to be raised for 1953 is estimated at \$110,000, an increase of \$12,668.44 over 1952 which is due to the inrease-in-ratables-and-an-anticipated rise in the County tax, rate. The amount to be raised by taxation for local tax purposes in 1953 s \$418,444.89, an increase of \$62,-105.17 over 1952. The 1953 increase in operating appropriations is \$59, 729.25,"salaries and wages \$82.997.26 and other expenses \$26,782. The 1953 increase in salaries and wages provides for five per cent salary increases and increased personnel in the fire, road and sewer departnents. The 1953 increase in other expense appropriations is reflected primarily in the following: garbage
