



In Wil zoning districts, on-subset parking facilities for the storage of parking of self-propelled vehicles for the use of occupants. employees. and sanitariums, convaluesent homes; homes for the aged, asylums, and or-phanages, and for other similar uses, the off-street parking facilities rethe off-attest parking facilities re-ruited shell be within XKO feet of the buildings they are hitended to serve, measured between the nearest point of the off-street parking facilities and the nearest point of the building. The off-street parking facilities required for any of the other uses mentioned in Farzgraph 7 of this ordinance, or for similar 'uses, shell be within 1000 parking of self-propelled vehicles for the use of occupanta, employees, and parons of buildings erected after the stictive date of this ordinance and of such extensions, additions, en-lingement or changes in use of such buildings shall be provided in amounts not-less than hereinafter, specified, and shall not subsequently be reduced below the requirements of this ordisimilar uses, shall be within 1,000 of the building they are intended

for similar uses, shall be within 1,000 feet of the building, they are intended to serve, measured between the near-est point of the off-street parking facilities and the nearest point of the building. 10. In the case of mixed uses, the total re-quirements for off-street parking facilities-shall-be the sum of the re-quirements for off-street parking facilities for one use shall not be considered as providing required park-ing facilities for any other use except as harein specified for joint use. 11. 





Surprised or not, Alex has been sitting at that table on the second-Tuesday-of-every month since November, 1944, helping to make decisiony during a period which has seen the bank-triple Its denosits and assets and become increasingly useful to a growing community. What do bank directors talk about? "Money and people," answers Alex, "how to encourage people to deposit their money in the bank, now to run the bank most economically, how to lend and invest money so as benefit-both the bank and the townspeople.

Alex looks the part His spare figure and shock of steel gray -hair give him_an_air_of unobtrustive distinction. As a student at Rutgers, and as a Navy man in World War I, it never occurred to Alex that he might-someday become a bank director. He was moro-interested in writing humorous poetry (sample: "Ship me out to some tropic isthmus, where the statives never heard of Christmas");

But in 1025, Alex's father helped to organize the First National Bank, In the years that followed, Alex absorbed a good deal of financial knowledge and understanding of the relations between a bank and its community. When his father died in 1944, the directors asked Alex to come in with them. Somewhat reluctantly, he agreed.

"Thore-isn't-much horseplay-at a directors'-meeting. Handlingother people's money is serious business and there are many problems which must be solved. The percentag of the bank's assets which can safely be invested in mortgage, for example, and the maximum loan which should be made by a bank of our size. Errors in judgment here could have serious results."

Alex and his wife, Marjorie, have a married son and a 10-, month-old granddaughter, Kathle. Grandpa Alex thinks that Kathle is sure to become a bank director some day. "She shows no more interest in financial problems now than I used to."
