issued the necessary permits for the construction of the shopping center at the corner of Morris and Flemer avenues. Springfield's officials have approved the plans, the police and fire departments inspected them thoroughly and everybody signed them. Word from the office of Nicholas Angleton, head of the organization that will build this shopping center, announced that ground will be broken on this worthwhile project, probably, this month and the work rushed so that the lessees can aim at Fall openings.

Some discussion has been heard in Springfield deploring the fact that the plans, as accepted and approved by the Township, do/not show any Colonial design. Some of the more ardent devotees of this traditional style of architecture have asked for a meeting of various civic groups to discuss the possibility of requestng that blue prints be changed so as to conform, in some degree, to Colonial design.

The Sun still believes Springfield deserves permanent examples of historical values-but the timing is bad. Picking up all the loose ends in such a project as the proposed shopping center entailed considerable patience-selling and details. The package is complete-all the necessary signatures are on the papersand NOTHING SHOULD BE DONE TO HINDER OR DELAY THIS JOB. The-time-to-have insisted was when the plans were being drawn, when the architect started preparing for all the details in handling the many leases.

We have never met Mr. Angleton and we haven't liscussed this matter with him or any of his representatives. But we have gone through the back files of the Springfield Sun and there is every reason to believe that he wouldn't stand for being tripped up again -or even delayed at this point. Neither would we. If Grand Union, J. J. Newberry, Miles Shoe Store, Morey LaRue and the other tenants have\_decided on the style of store fronts=they want—and the leases were signed with those plans-made a part of the contract-Mr. Angleton has every right in the world to proceed without any sentiment being cooked up\_against the center. And, it is hoped that Springfield will encourage and accept this spending of a half million dollars herewithout repeating another All State Insurance-or any of the other big ones that got away.

Jay Levins, one of Spring field's most articulate boostrs, takes former Mayor Robert W. Marshall to task not only as a private citizen but also as Chairman of the Committee for Harold Nenninger, for statements made in last week's issue of the Springfield Sun as part of he campaign\_for\_Township Committee in the forthcom-

ing primaries. Mr. Levins takes off the kid gloves in aiming his verbal guns at Marshall which should increase the tempo of the campaign to nominate the man who will be on the Republican ticket for Township Committee in the general elections this Fall. Following-is-the-complete-text of Mr. Levin's statement:

"If there were any evidence of dishonesty," said Mayor Binder, "Marshall should have told his story to Springfield residents when he discovered it. He should have named people involved and he owed to those whom he represented to speak out at that time instead of condoning whatever he says he discovered.

"Bob Marshall should be called upon to prove his charges or retract his accusations as being nothing but political folderol. These are insinuations I don't have to take and all people who know me resent it. It wasn't fair.....
